

**CA Tier Update April 7th** – San Bernardino, Riverside, San Diego, Ventura, Santa Barbara and Tulare counties were granted movement to the less restrictive Orange Tier. Click <u>HERE</u> to see the latest information for your county.

California also hit another milestone, with the administration of 4 million vaccines, this key factor or Vaccine Equity Metric has allowed for the tier assignment revision and reflect the shift in Blueprint tier thresholds. The less restrictive Orange Tier allows for expanded indoor operations including restaurant indoor service to increase to 50% of capacity, gyms to operate at 25% indoor capacity and theatres to operate at 50% capacity or fewer than 200 people whichever is less. It also allows for indoor operations for breweries, wineries, distilleries, bars and family entertainment centers to operate.
