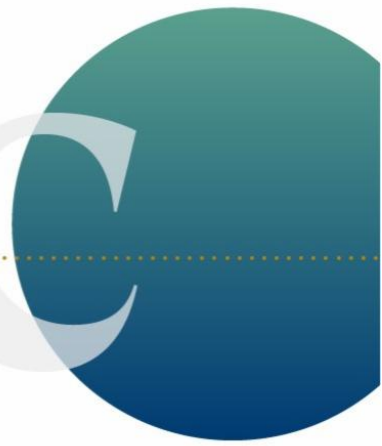

Dear Merchant,

The application period for a fourth Business Assistance Grant program was announced today. Eligible businesses and nonprofit organizations that did not receive a grant in any of the County of Ventura's previous Covid-19 Business Assistance Grant programs can apply for a \$10,000 grant. **The application window begins at 8:00 a.m. on August 19 and ends at 6:00 p.m. on September 2.**

General eligibility requires businesses and nonprofits have a physical location and operations in Ventura County, have been in business prior to 2021, show annual gross revenues between \$25,000 and \$2.5 million, and have a history of compliance with Covid-19 safety standards. Interested organizations can find more information and apply during the application window at www.VCBusinessGrants.org

The County Board of Supervisors has supported more than \$65 million in grants to help local businesses move forward.

The County of Ventura is launching a fourth COVID-19 Business Assistance Grant Program for business and nonprofit organizations that did not receive a grant during any of the County's previous business grant programs. Businesses and nonprofits based in Ventura County may be eligible for a \$10,000 grant. The County Board of Supervisors has supported more than \$65 million in grants to help local businesses move forward.

APPLICATION WINDOW:

Thursday, August 19 at 8:00 am – Thursday, Sept 2 at 6:00 pm

BASIC ELIGIBILITY CRITERIA

- Must have a physical location and operations in Ventura County
- Must have been in business prior to 2021
- Annual gross revenue must be between \$25,000 and \$2.5 million
- Must have not received a County of Ventura COVID-19 Business Assistance Grant (prior grant recipients are not eligible to apply)
- Nonprofit organization must be qualified as exempt from taxation under Internal Revenue Code section 501(c)(3), 501(c)(6), or 501(c)(19)
- Must have a history of compliance with Covid-19 safety standards

REQUIRED DOCUMENTS

- Photo ID
- Tax Returns from 2019 or 2020
- Proof of Physical Address in Ventura County (See website for a list of acceptable documents)
- Signed and dated IRS Form W-9
- Nonprofits must show IRS Determination Letter

El Condado de Ventura va a lanzar un cuarto Programa de Subvenciones de Asistencia Comercial por el COVID-19 para empresas y organizaciones sin fines de lucro que no recibieron una ayuda durante ninguno de los programas anteriores de subvenciones de asistencia comercial del Condado. Las empresas y organizaciones sin fines de lucro basadas en el Condado de Ventura pueden ser elegibles para una ayuda de \$10,000. La Junta de Supervisores del Condado ha aportado más de \$65 millones en subvenciones para ayudar a las empresas locales a avanzar.

CRITERIOS BÁSICOS DE ELEGIBILIDAD

- Debe tener una ubicación física y operaciones en el Condado de Ventura
- Debe haber estado operando antes de 2021
- Los ingresos anuales brutos deben estar entre \$25,000 y \$2.5 millones
- No debe haber recibido una Subvención de Asistencia Comercial por el COVID-19 del Condado de Ventura (los receptores anteriores de ayuda no pueden solicitarla)
- Las organizaciones sin fines de lucro deben estar calificadas como exentas de impuestos según la sección 501(c)(3), 501(c)(6) o 501(c)(19) del Código de Rentas Internas
- Debe tener historial de cumplimiento con las normas de seguridad contra el Covid-19

DOCUMENTOS NECESARIOS

- Documento de Identidad con Fotografía
- Declaraciones de Impuestos de 2019 o 2020
- Prueba de Dirección Física en el Condado de Ventura (consulte en la página web una lista de documentos aceptables)
- Formulario W-9 del IRS firmado y fechado
- Las organizaciones sin fines de lucro deben mostrar la Carta de Determinación del IRS
